All prizes must be picked up on the day of the trial. NONE will be mailed. A qualifying score is required for all awards.

ENTRY INFORMATION

ENTRY FEE per day: \$50.00 per trial or test entry. We will accept "day of test" entries for Herding Instinct Certification at \$55 per entry (if limits have not been reached). Please complete the entry form and bring it to the Trial for day of trial entries. Day of Test Instinct entries will be accepted up to 30 minutes prior to the start of the Test Classes. "For Exhibition Only" entries will not be accepted.

ENTRY FEE for Farm Dog Certification: \$35.00 or two entries of the same dog for \$60.00. We will accept day of test entries for Farm Dog Certification for the same fees (if limits have not been reached). Day of Test entries will be accepted up to 30 minutes prior to the start of the first Farm Dog Test.

ENTRY PROCEDURES:

Telegraph, telephone and unsigned entries cannot be accepted. Entries not on Official AKC Entry Forms and Photocopies of Entry Forms without Agreement and Rules on the reverse side of the Official AKC Entry form are NOT ACCEPTABLE. Any entry sent via any Express service method must have the signature waived. No entry shall be made, and no entry shall be accepted that specifies any condition as to its acceptance. No refund for duplicate entries.

Entries close at 6 pm on Sept 23, 2020 or earlier if class limits have been reached. On the day that the limit is reached, if more entries have been received than can be accepted, all entries received on that date will be placed in a lottery to determine which will be accepted. Those not accepted will be placed on a waiting list in case accepted entries drop out before the closing date.

Make all Checks and Money Orders payable to Central New York Shetland Sheepdog Club. Please send checks or money orders with entries. Returned checks do not constitute a valid entry fee. The show secretary will add a collection fee of \$30.00 to the amount for each returned check.

Entry Fees shall not be refunded in the event that a dog is absent, disqualified, excused by Veterinarian or Judge, or barred from competition by action of the Show Committee. If because of riots, civil disturbances or other acts beyond the control of the management it is impossible to open or to complete the show, no refund of entry fee will be made. Owners are responsible for errors in making out entry forms, whoever may make such errors, and no entry fee will be refunded in event of such errors or cancellation of entries after the published closing date.

The Club may decline any entries for cause and may refuse to receive or may remove any dog on account of disease, viciousness or other causes, and no one shall have any claim or recourse against the Club or any official thereof.

NOTE

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

LIVESTOCK & FACILITY

Grace Farms and Central Bark are located on an 80-acre Christmas Tree and Aquaculture farm. Restaurants and lodging are available nearby.

Livestock: Hair sheep (Katahdin and Dorper/ Dorper Crosses) (3 per run) that are accustomed to all breeds of working dogs. Mixed Banty/Call ducks (5 per run).

Working Areas: Course A for sheep: 100' x 200'; Course A for ducks: 100'x 50'; PT Duck: 100' x 50'; HT sheep: 100' x 100'; HIC: ~50-foot round.

Directions to Vet Clinic: Head South on Gunther Road (Left out of driveway). Take a left on Route 49 into Central Square. In 4.1 miles Rt. 81 will be on your right. Take I-81 South Bound (right onto the on ramp) towards Syracuse for 10 miles and take exit 29S to merge onto I-481S toward Dewitt. Stay on I-481S for 8 miles. Take exit 4 for Interstate 690 West for a mile. Take exit 17 for Bridge Street toward East Syracuse. Turn right onto Bridge Street and Vet Clinic is 0.4 miles on the right.

Smoking will not be allowed inside any building on the premises. Areas outside the barn in the gravel are designated as smoking areas.

Please do not let dogs pee on barns or buildings.

Barking dogs must be parked in the back-parking lot away from the road and neighbors. This will be well labeled.

People and dogs are not allowed in the barns unless they are working, or the Farm Dog testing requires them to take that path.

Dogs must be ready for their classes. Test/Trial judges may refuse to judge any dog that does not appear within five minutes of being called for its run. The Club and the Trial Secretary have no obligation or responsibility to provide service through a public address system or stewards/runners for the purpose of calling or locating dogs that are not brought into the arena when required.

Only dogs entered at this Test/Trial will be allowed within the Test/Trial limits except trained dogs used by the facilitators to settle or control the stock.

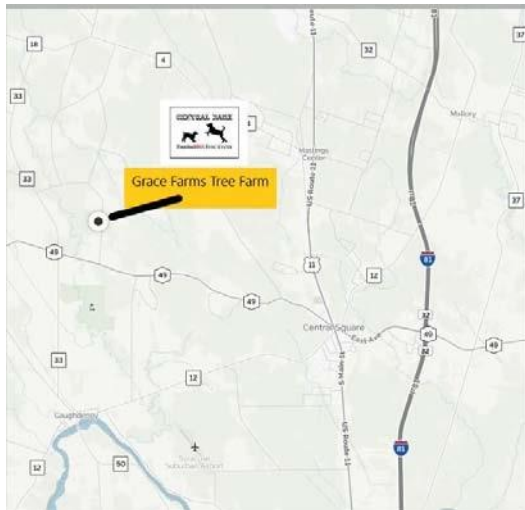
All dogs present must be held on leash or otherwise restricted except when competing. Under no circumstances will dogs be allowed to disturb the resting stock or interfere outside the arena with another dog's performance in the arena. Any dogs aggressive to persons or stock will be removed.

FARM DOG CERTIFICATION

The Farm Dog Certified test is open to all dogs. The program provides an opportunity for all dogs to apply their basic training in a novel environment, demonstrating their natural capability and trainability to work in partnership with their human companions.

The Farm Dog Certified test is designed to assess the overall conduct of a dog within a typical farm environment. The dog must demonstrate self-control when exposed to livestock and other unique sights, sounds and scents. The dog should exhibit confidence and a willingness to comply with instruction when confronted with a variety of situations.

The Farm Dog Certified test provides a series of 12 exercises that represent situations a farm dog would encounter in a typical farm environment and an overall assessment.

- 1) GREET JUDGE – INITIAL DOG APPRAISAL
- 2) PERFORM A WALKING PATTERN AROUND FARM ENVIRONMENT / PASSIVE STRANGER
- 3) JUMP ON HAY/STRAW BALE
- 4) WALK BY FARM ANIMALS
- 5) WALK OVER OR THROUGH UNUSUAL SURFACES
- 6) SUPERVISED SEPARATION
- 7) PASS THROUGH A GATE
- 8) HANDLER FEEDS LIVESTOCK
- 9) REACTION TO ANOTHER DOG
- 10) REACTION TO NOISE DISTRACTION
- 11) DOG APPROACHES LIVESTOCK
- 12) PHYSICAL EXAMINATION

In addition to passing each element of the test, the Judge shall, at the end of the test, determine if the dog consistently exhibited traits that would distract from being a useful working farm dog. This might include incessant barking, chronic distraction, constant tugging on the leash, timidity, lack of interest, or over exuberance. This would address a situation wherein a dog may meet the minimum requirements for each test element but fail in the spirit of performing as a confident working partner on a farm or premises

BE SURE to check if the hotel still accepts dogs when making your reservations. Please be sure that you pick up after your dogs so that these hotels will continue to accept dogs.

AGREEMENT

I (we) agree that the club holding this Herding Test or Trial has the right to refuse this entry for cause which the club shall deem to be sufficient. In consideration of the acceptance of this entry and of the holding of the Herding Test or Trial and of the opportunity to have the dog tested or judged and to win ribbons, prizes or trophies, I (we) agree to hold the AKC, the event-giving club, its members, directors, governors, officers, agents, superintendents or show secretary and the owner or the lessor of the premises, any provider of services that are necessary to hold this event, any employees or volunteers of the aforementioned parties, and any AKC approved judge judging at this event harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or upon the Herding Test or Trial premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim for loss, injury or damage to this dog, whether such loss, disappearance, theft, damage or injury be caused or alleged to be caused by the negligence of the club or any of the parties aforementioned or by the negligence of any other person, or any other cause.

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves), or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other persons. I (we) agree that a cause of action, controversy or claim arising out of or related to the entry, exhibition or attendance at the event between AKC and/or the event-giving club and myself (ourselves) or as to the construction, interpretation and effect of this agreement shall be settled by arbitration pursuant to the applicable rules of the American Arbitration Association. However, prior to arbitration all applicable AKC Bylaws, Rules, Regulations and Procedures must first be followed as set forth in the AKC Charter and Bylaws, Rules, Regulations, published policies and guidelines. Additionally, I certify and represent that the dog (s) I have entered in or brought to this event is(are) not a hazard to other dogs, animals, or people and that they are healthy and adequately protected from communicable infectious diseases. I (we) agree to pay for any livestock injuries or replacement value in the event of death to any livestock caused by my (our) dog. In case of any injury to any stock caused by the dog entered, I (we) will assume total responsibility for any damage. I (we) agree to pay the full market value of the injured animal in case of serious injury or the veterinarian bill if the injury is slight. The valued price for each animal is \$250.00 U.S. dollars for sheep and \$100.00 for ducks. All persons attending this dog show hereby waive any claim for damages against the show-giving club or its members, in the event a motor vehicle must be entered to rescue a dog from overheating or suffocation due to improper ventilation.
