## A & B CLASSES IN Barn Hunt

You can run A classes OR B classes on a weekend. You cannot switch between A and B for the duration of the weekend.

For instance \*if\* you are running A classes on a weekend and finish your title you must move up to the NEXT A class OR stay in the A class you finished for a “bumper leg”.

You may enter any B level class for which you have already titled. If you are working on a Senior A title (for instance you do NOT have the RATS title yet) you may run Novice B or Open B.

If you have a RATM and are working for the RATCH- you must be in the B classes.

### GENERAL EXHIBITOR INFO

**Crating:** There is only OUTDOOR crating – no indoor crating. Lots of room to walk your dogs on the property

**Loud/Disruptive Dogs:** Please keep dog barking to a minimum so as not to disturb the working dogs. Exhibitors are expected to know the BHA rules as far as aggression is concerned, both on and off the course.

**Instinct Test:** Dogs may enter both the Instinct Test and Novice in the same trial until the dog has earned the RATN title. Once RATN is obtained you can no longer enter the Instinct Test.

**Move-ups:** Move-ups will be allowed until 30 minutes BEFORE the start of each Trial. You must sign a move-up form at the Secretary’s table. There may be an applicable payment, please pay at that time.

**Collars/Leashes:** NO FLEXIS, HEAD HALTERS or ECOLLARS IN USE. All dogs must be on leash at all times except when in the ring. Dogs must “run naked” in the ring. Dogs should be brought to the ring with collars/harnesses that can easily (quickly) be removed and replaced.

**Bitches in Season:** Bitches in Season (BIS) MAY compete in this event. They will be run at the end of each class. BIS must wear pants at all times when not being pottied, including while in the ring. Owners of BIS should seek out a committee member upon arrival to be directed to the designated parking and walking area. Advance notice to the secretary is greatly appreciated if you will be bringing a BIS! Failure to notify the secretary and fellow competitors will result in dismissal from the show grounds.

**Parking:** There is a large lot with plenty of parking.

**Camping:** There is very limited self-sufficient camping on the grounds (NO hook ups). Please contact the Trial Chair before sending in your entry if you need to camp to be sure there is space.

**Exhibitor Notes:** - Exhibitors not attending the General/Judge's briefing will still be held responsible for knowing the information given in these briefings. - Any dog that is sick, injured or lame will be excused from trial grounds. - Please be considerate about picking up after your dogs and leaving the grounds as you found them. Any exhibitor failing to do so may be excused without benefit of refund if the Trial Committee deems the exhibitor to be in violation of this requirement, per BHA Regulations. Exhibitors are responsible for being ready to enter the blind on time. The judge need not wait for any dog holding up the class.

### **DIRECTIONS to 2019 Risser Road Canandaigua, NY 14424:**

From the West on Thruway – take Exit 44 (Canandaigua). Follow Route 332 to Route 96. Turn left onto Route 96. Take your 3rd right onto Payne Road. Cross 2 intersections and Payne Road becomes Risser Road. Event location will be on your left. Driveway is flanked by 2 large columns of horse shoes.

From the East on Thruway – take Exit 43 (Manchester). Turn right onto Route 21. Turn Right onto Route 96. Take your 5th left onto Payne Road. Cross 2 intersections and Payne Road becomes Risser Road. Event location will be on your left. Driveway is flanked by 2 large columns of horse shoes. From the North – take Route 21 South. Turn Right onto Route 96. Take your 5th left onto Payne Road. Cross 2 intersections and Payne Road becomes Risser Road. Event location will be on your left. Driveway is flanked by 2 large columns of horse shoes.

From the South – take Main Street/332 North through Canandaigua. Turn right onto North Street. Stay straight onto Macedon Road. Make slight left onto Risser Road. Event location will be on your right. Driveway is flanked by 2 large columns of horse shoes.

## COVID 19 RULES/CHANGES:

- We may not be able to have a potluck lunch or provide a community lunch. We will update you on this as we get closer to the date but be prepared to bring your own food for the day
  - We will be flexible with refunds and waitlists if the need arises; we will also continue to take day of show entries if we do not fill the trial by the closing date
  - We may not be able to have our planned massage therapist and animal communicator based on safety concerns in our new world. We will keep you updated on this as the trial gets closer
  - Please be flexible with judge changes, length of class times, class changes and ring locations. We utilize international judges and we may not have a finalized judge and/or relief judge list until right before the trial. Also, the new changes are put in place for your safety and will definitely increase the length of the trial ... BUT YOU AND YOUR PUPS ARE WORTH IT !
  - Everyone must wear a mask at all times. We cannot guarantee that masks will be available on-site so please be prepared to bring your own mask
  - There are many changes related to leash and rat handling. Be sure to check out the guidelines – see link below. A copy will also be available for your review at the trial site
  - Please sign the UPDATED COVID- 19 waiver required by Barn Hunt Association, LLC and include it with your entry. If you do not include it with your entry, there will be copies available at the trial site
  - We encourage you to bring your own wipes and hygiene supplies. We will have lots on-site but your own supply is helpful, too !
