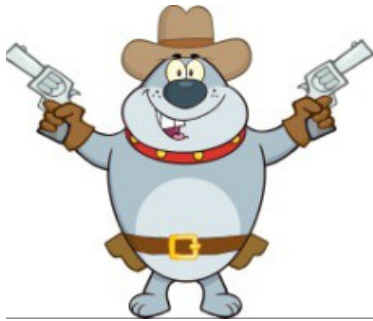

Closing date for entries is September 5th. This is also the last date to pull from the trial with a guaranteed refund. Full refund given if pulled before closing date OR after closing *IF* there is a waitlisted dog able to take the spot. If there is NO waitlist, there will be no refunds given if the dog is pulled POST closing date.

Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee. No entry fees will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, acts of a public enemy, or any other causes beyond the control of the organizing committee.

GENERAL EXHIBITOR INFO

Crating: There is NO indoor crating. Please be prepared to crate from your vehicle or under pop up tents etc. Parking will be in a large grassy field. All dogs must be crated or on a leash at all times except when running. No ex-pens may be used.

Loud/Disruptive Dogs: Please keep dog barking to a minimum so as not to disturb the working dogs. Exhibitors are expected to know the BHA rules as far as aggression is concerned, both on and off the course.

Instinct Test: Dogs may enter both the Instinct Test and Novice in the same trial until the dog has earned the RATN title. Once RATN is obtained you can no longer enter the Instinct Test.

Move-ups: Move-ups will be allowed until 30 minutes BEFORE the start of each Trial. You must fill out a move-up form at the Secretary's table. There may be an applicable payment, please pay at that time.

Collars/Leashes: NO FLEXIS, HEAD HALTERS or ECOLLARS IN USE. All dogs must be on leash at all times except when in the ring. Dogs must "run naked" in the ring. Dogs should be brought to the ring with collars/harnesses that can easily (quickly) be removed and replaced.

Bitches in Season: Bitches in Season (BIS) **MAY** compete in this event. They will be run at the end of each class. BIS must wear pants at all times when not being pottied, including while in the ring. Owners of BIS should seek out a committee member upon arrival to be directed to the designated parking and walking area. Advance notice to the secretary is greatly appreciated if you will be bringing a BIS! Failure to notify the secretary and fellow competitors will result in dismissal from the show grounds.

Parking: Event takes place on a personal residence, please park in designated areas.

Camping: There is **very limited** self-sufficient camping on the grounds (NO hook ups). Please contact the Trial Chair before sending in your entry if you need to camp to be sure there is space.

Height Classes: 13" and under – Small, 13.1"-18" – Medium, 18.1" and over – Large

Exhibitor Notes:

- No General/Judge's briefing – read your emails! You are still responsible for knowing the information given.
- Any dog that is sick, injured or lame will be excused from trial grounds.
- Please be considerate about picking up after your dogs and leaving the grounds as you found them. Any exhibitor failing to do so may be excused without benefit of refund if the Trial Committee deems the exhibitor to be in violation of this requirement, per BHA Regulations.
- Please be prepared for any weather, consider both you and your dog.
- Exhibitors are responsible for being ready to enter the blind on time. The judge need not wait for any dog holding up the class.

PLEASE NOTE:

A photographer may be on site. By entry of this event, you acknowledge that you are aware and accept the Fact that you or your dog may be photographed/filmed and that these photographs/video may be used by East Wind’s Canine Events or Whiskers Barn Hunt Club for promotional reasons.

Any Judge of Record at the Event may be used as a Load Balancing Judge in any ring. Judge of Record and Event Official dogs may be judged prior to the Event start or as the first dogs of the Event.

DIRECTIONS to 2019 Risser Road Canandaigua, NY 14424

From the West on Thruway – take Exit 44 (Canandaigua). Follow Route 332 to Route 96. Turn left onto Route 96. Take your 3rd right onto Payne Road. Cross 2 intersections and Payne Road becomes Risser Road. Event location will be on your left. Driveway is flanked by 2 large columns of horse shoes.

From the East on Thruway – take Exit 43 (Manchester). Turn right onto Route 21. Turn Right onto Route 96. Take your 5th left onto Payne Road. Cross 2 intersections and Payne Road becomes Risser Road. Event location will be on your left. Driveway is flanked by 2 large columns of horse shoes.

From the North – take Route 21 South. Turn Right onto Route 96. Take your 5th left onto Payne Road. Cross 2 intersections and Payne Road becomes Risser Road. Event location will be on your left. Driveway is flanked by 2 large columns of horse shoes.

From the South – take Main Street/332 North through Canandaigua. Turn right onto North Street. Stay straight onto Macedon Road. Make slight left onto Risser Road. Event location will be on your right. Driveway is flanked by 2 large columns of horse shoes.

- Please make a point to read and re-read the additional rules and requirements regarding Covid-19.
- We will send important information out in our initial confirmations as well as our final confirmation so PLEASE make sure you check them when they arrive.

- Please plan accordingly to limit the length of time you are at the trial.
- We have implemented an "On Deck" area for the dogs waiting to fill the next blind. Blinds are 3 or 4 dogs depending on which ring you're competing in.
- Hand sanitizer and hand washing stations will be available but if possible, please bring your own hand sanitizer. Masks will not be provided to competitors, please bring your own.
- There will be no pot luck or food provided to competitors, please plan accordingly.
- Upon arrival, look for the picnic table between the field and office. This will have posted information that should answer any questions. Club members are available as well to help.
